A

BILL

to provide for the withdrawal of certain further sums from and out of the Consolidated Fund of the State of Goa for the services and purposes of the financial year 2024-25.

BE it enacted by the Legislative Assembly of Goa in the Seventy-fifth Year of the Republic of India, as follows:—

- 1. Short title.— This Act may be called the Goa Appropriation (Vote on Account) Act, 2024.
- 2. Withdrawal of Rs. 11189,81,90,000/- from and out of the Consolidated Fund of the State of Goa for the financial year 2024-25.— From and out of the Consolidated Fund of the State of Goa, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule to this Act amounting in the aggregate to the sums of eleven thousand one hundred eighty nine crore eighty one lakh ninety thousand rupees towards defraying the several charges which will come in the course of payment during the financial year 2024-25 in respect of the services and for purposes specified in column (2) of the said Schedule.
- 3. Appropriation.— The sums authorised to be paid from and out of the Consolidated Fund of the State of Goa under this Act, shall be appropriated for the services and purposes expressed in the Schedule to this Act in relation to the said financial year.
