The following may be added at the end of the Motion, namely “but regrets that the Address fails to mention about :

The Government has failed to prevent the imminent conversion of our beautiful state of Goa By not able to ensure the diversion of MHADEI RIVER and not able to stop the central government from approving the DPR and further converting Goa to a Coal Hub. It has failed to listen to the voice of the people and protect the environment, forest and wild life of Goa, by not scrapping the 3 linear projects, which are all intended to only cater transportation of Coal to Goa.

a)The Government has failed to protect the Lifeline of Goa River Mhadei. The Government has adapted to a lethargic approach in dealing with the matter, thus allowing the Diversion of Water.

b) The Government has failed to provide approvals for Western Bypass on Stilts in Benaulim, due to which flooding is imminent.

c) The Government has failed to construct Panchayat Ghar for VP Seraulim & VP Colva.

d) The Government has failed to resolve local issue and grant funds to construct Carmona Panchayat Ground.

e) The Government has failed to allocate appropriate funds and resolve local sentiment and construct a Daughter Primary Health Centre in Benaulim Village.

f) The Government has failed to plug in raw sewerage discharge into RIVER SAL, and failed to carry out a fare investigation of why the raw sewerage is being discharged into River Sal.

g) The Government has failed to complete the rejuvenation of Colva creek and has mentioned its completed on Pg-19 of his speech.

h) The Government has failed to allocate land and construct new police station for Colva.

- i) The Government has failed to allocate land and construct electricity sub-station proposed at Colva.
- j) The Government has failed to provide proper Infrastructure for Vehicles and Pedestrians across the State which has resulted in many Fatal Accidents, Injuries to Commuters and Pedestrians & Damage to Vehicles.
- k) The Government has failed to provide uninterrupted Water Supply to Domestic, Commercial and Industrial Units in Goa. The Government has failed in providing 100% Tap Water Connections to all the households in Goa.
- l) The Government has failed to provide uninterrupted Power Supply to Domestic, Commercial and Industrial Units in Goa. The Government has failed in providing 100% Electricity to all the households in Goa.
- m) The Government has failed to provide the Bal rath drivers increment in their salaries and also not being paid for 12 months.
- n) The Government has failed to disburse the Ladli Laxmi Scheme from 2016 till date. (700 plus beneficiaries pending from Benaulim constituency)
- o) The Government failed to keep the Beaches of Goa Clean by effectively undertaking Beach Cleaning Work and Safe by deploying sufficient tourist police on beaches.
- p) The Government Failed in implementation of “Open Defecation Free”policy. In reality, people are still awaiting toilets in various Villages across the State. (No toilets at Seraulim & Cavelossim Anganwadi till date in Benaulim Constituency)
- q)The Government has failed to make Goa State Women’s Commission fully functional. Although 51% of Goas population is women.
- r) The Government has failed to control the price rise of Essential Commodities, Vegetables and Fruits in the State of Goa.
- s) The Government has failed to provide counselling to Government staff and public at large, due to which govt staff and general public suicide cases are on an increase.
- t) The Government has failed to enhance the quality of education, improve infrastructure and introduce new technologies in the academic curriculum. State has failed to initiate the process of implementation of National Education Policy in phased manner.
