QUESTION O01A Will the Minister for Finance be pleased to state: a) the status of the Atal Setu Project as on date along with the details of the works completed and works pending as on date with the reasons for pendency;	ANSWER By Shri Pramod Sawant, Chief Minister/Finance Minister Sir, the north viaduct, cable stayed portion in river and south side viaducts were completed and opened to traffic in February 2019. The work of completion of down ramp to Panaji city, hotmixing of service roads in Porvorim and Panaji side are pending. The other activities such as drains, footpath, installation of fenders for pile caps in river (04 nos.), inspection platform for cable stayed pylons (04 nos.), installation of electrical poles for bridge and service roads will be taken up shortly. Initially, the delay was caused due to the application filed by Goa Foundation before Hon'ble National Green Tribunal (NGT), Pune Bench. The piling
